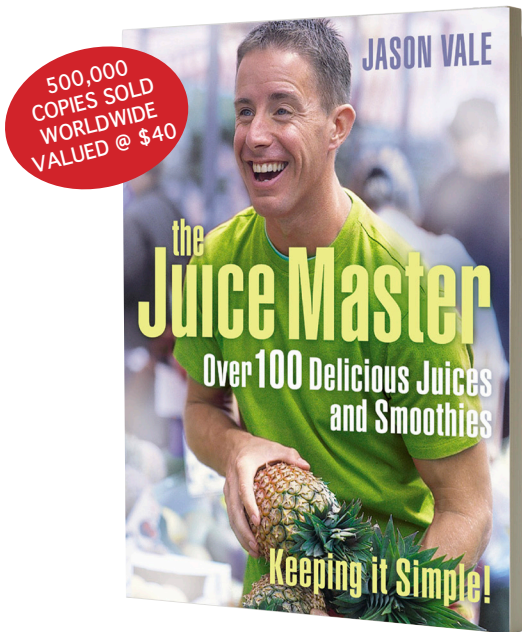

TERMS & CONDITIONS
